



## MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding is made and executed  
on FRIDAY, 15<sup>th</sup> September, 2017

### **Between**

*Department of Computer Science, Higher and Technical Institute Mizoram (HATIM),  
Lunglei (Hereinafter referred to as "HATIM", which expression shall include its  
successors and permitted assignees) on FIRST PART*

### **And**

*National Institute Of Electronics & Information Technology, ( NIELIT), Lunglei  
(Hereafter referred to as "NIELIT", which expression shall include its successor and  
permitted assignees) on SECOND PART.*

**And whereas** HATIM is one among the noteworthy academic institutes in Mizoram offering Bachelor of Computer Application, UG Programme in Computer Science

**And Whereas,** NIELIT, (a registered Autonomous Scientific Society of Department of Electronics and information technology (DeitY), Ministry of Communications & Information Technology, Government of India, New Delhi), Lunglei Center, is desirous of associating with each other to expertise students and Staff alike of HATIM on "**Course on Computer concepts**" (CCC) as an addition to HATIM's Add-On Course in co-ordination with HATIM – Department of Computer Science Faculties and HoD / Principal.

The main objectives of NIELIT is to provide and generate for willing learners quality manpower and develop skilled professionals in information, electronics and Communication technology (ICT) and allied by providing world class education and training and accreditation **services**

Now therefore, in consideration of the premise and actual covenants herein contained, it is agreed by both HATIM and NIELIT as under.

- 1) "MoU" shall mean this Memorandum of Understanding executed between HATIM and NIELIT on FRIDAY, 15<sup>th</sup> September, 2017 for "**Course on**

**Computer Concepts” which is a certificate course offered by NIELIT** under **HATIM as a Study Centre** for the students and any staff member willing to learn and enhance their basic IT skills.

- 2) The headings/subheadings/titles sub-titles are only for the sake of convenience and shall not be interpreted to restrict or otherwise affect the meaning or import of the clauses, which shall be interpreted solely in light of the contents thereof.
- 3) No Party shall act on behalf of the other party to contractually bind the other party under the terms of this MoU having first obtained the other party's written agreement.
- 4) This MoU relates solely to the **intention of the parties**, wherein HATIM and NIELIT jointly work together and shall not extend to any other activity or create a partnership between the parties hereto and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in respective fields, except to the extent expressly provided herein, which is to provide an equal opportunity to education and IT skills of students or staff enrolled under the ADD-ON Course and nothing more.
- 5) **The course syllabus** be structured and given by NIELIT which will be taught by the faculty of the Dept. of Computer Science, HATIM under the Head of the Department.
- 6) **Course/ Lecture Arrangement:**
  - a) The course shall be taught for a **semester** and the lectures must consist of **30 hours of lectures/classes** or more.
  - b) A separate time be allotted for this **CCC** and not to be included in the regular time table of the Under-Graduate Curriculum under Mizoram University.
- 7) **Duration / Terms:**
  - a) The duration of this MoU shall be considered effective starting from the date of signing of MOU and shall be extended on understanding as may be deemed necessary from time to time. The Validity of this agreement stands indefinite on mutual consensus.

- b) Each party shall have the right to withdraw from the Agreement on Six Months' notice (A semester) in writing. Such a termination will, however, not affect ongoing courses already approved jointly or under progress under the terms of this memorandum.
- c) All Notices and requests, and other information and communications relating to this MoU shall be in writing in the English Language.
- 8) **Resource Allocation:** HATIM shall provide the infrastructure required for the course that includes all hardware requirements such as systems, Projectors etc. for the Expert Lectures, also the labs and other equipment available in the computer lab.
- 9) **Certification:** Upon completion of the course, NIELIT will conduct the qualifying exams and will be solely responsible for qualification of degree for registered students. That is, the students qualifying the technical assessment shall be certified with completion certification by NIELIT only.

#### **Signature of the Memorandum of Understanding (MoU)**

In witness whereof, the parties to this MOU through their duly authorized representatives have executed this MOU on the days and dates set out below, and certify that they have read, understood, and agreed to the terms and conditions of this MOU as set forth herein.

This MoU has been executed in two originals. The NIELIT and the other by Higher and Technical Institute Mizoram (HATIM), Lunglei have retained one of these.
