

MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding is made and executed on this day, 27th March 2023

Between

Department of Philosophy, Lunglei Government College (LGC), Lunglei (Hereinafter referred to as "LGC", which expression shall include its successors and permitted assignees) on FIRST PART

And

Department of Philosophy, Higher and Technical Institute Mizoram (HATIM), Lunglei (Hereafter referred to as "HATIM", which expression shall include its successor and permitted assignees) on SECOND PART.

This Memorandum of Understanding (MoU) between LGC and HATIM is entered into for the purpose of a **Student Exchange Programme** between the two parties, the objective of which is to promote and enhance student exposure, student learning, practicality and sharing of knowledge in the field of Philosophy.

Now, therefore, in consideration of the premise and actual covenants herein contained, both LGC and HATIM, agree to the following undermentioned terms and arrangements:

A. Terms of the MoU:

- The two parties agree to enter into a Student Exchange Programme agreement during and or within the academic year 2022-2023.
- (ii) The participating students will constitute the VI Semester of respective colleges.





- (iii) Each institution may send at least one or two faculty to participate in the exchange programme. The number of the faculty may either be increased or decreased subject to mutual agreement of both institutions.
- (iv) Each institution will appoint an individual to act as the coordinator for the exchange. The exchange is co-ordinated in LGC through the Coordinator, Faculty Exchange Programme and in HATIM through the Coordinator, Faculty Exchange Programme.
 - (v) The host institutions will have the right to refusal of any candidate who may appear to be unacceptable for the exchange. Each sending institution will follow the exchange application deadline set by the receiving institution.

B. Financial Arrangements:

- (i) Bearing in mind the proximity of both institutions, no TA/DA will be paid to the respective participants be either institution.
- (ii) However, the VI Semester of LGC will be given a sum of rupees 500/- as a group to cover travel expenses.

C. Resources and Regulations at the Host Institution:

- (i) Students participating in the program will be free to choose courses or topic (s) of his/her choice provided that it is within the purview of the subject matter of "Philosophy" in purview of the syllabus from the affiliated university, Mizoram University
- (ii) At the end of the exchange programme, the host institution shall send an official report and/or transcript of their academic achievement to the home institution.
- (iii) Students participating in the programme are subject to the rules and regulations of the host institutions. The host institution reserves the right to dismiss any participating students at any time for academic or personal misconduct. The dismissal of a participant shall not abrogate the agreement for the arrangements regarding other participants.

D. Duration, Amendment and Termination of Agreement:

to assess the success of the exchange and will determine whether to continue, modify

- or discontinue the MoU. Each Party reserves the right to terminate this MoU upon one month's written notice to the other.
- The proposed duration of the student exchange programme is set to take place within two consecutive days, i.e., 30th and 31st March, 2023.
- The MoU shall take effect when signed by both parties, and will remain in effect until (iii) the end of the 2022-2023 academic session.

D. Conduct of Student Exchange Programme:

The Student Exchange Programme may be conducted at Higher and Technical Institute Mizoram through offline mode where students are expected to be physically present throughout the programme.



STUDENT EXCHANGE PROGRAMME

The Students' Exchange Programme between Higher and Technical Institute Mizoram and Lunglei Government College was successfully organized as a two-day program on the 30th and 31st of March, 2023 to provide a platform for students to experience, engage and learn more about philosophy.

On 30th March 2023, the students of LGC, accompanied by F. Lalremsanga, Assistant Professor met the Principal of HATIM shortly after arriving, followed by a quick photo session, after which the students attended normal classes following the scheduled class timing at the host institution. The students attended a lecture by each faculty from the host institution.

In total, there were seven students from LGC and two students from HATIM who participated on the first day of the program. Students were alert, attentive, and interactive in class.

On 31st March 2023, the first session, "Let's talk about Career Opportunities" welcomed Chawngdingpuii Chawngthu, Advocate, as a resource person to enlighten us on law and philosophy, the importance, significance, and role of philosophy in the study of law. The second session opened a Q&A and Open House Discussion. Students

showed deep interest and enthusiasm in these sessions which was evident from their active participation of students.

The second day of the program also included the second and fourth-semester philosophy core students from HATIM to attend the program. Five students, one faculty from LGC, and nine students and three faculties from HATIM participated on the second day of the program. Students were also given assignments, to watch and submit a write-up of their philosophical reflections on a movie titled "*The Truman Show*" (1998).

We owe the success of the program to the cooperation of all the students and faculties involved.
